 The following information, extracted from the *Judiciary Law*, is given for the benefit of the Sheriffs, Clerks, and all others concerned in the Courts, as the said Law cannot be printed immediately, viz.
SUPERIOR COURT, twice a year.
 First Term commencing in Camden and Washington, the first on Monday in January next, the Monday after in Glynn and Greene, the Monday after in Liberty and Franklin, the Monday after in Chatham and Wilkes, the second Monday after in Effingham and Richmond, and the Monday after in the county of Burke, and that the counties from Burke to Camden inclusive be the eastern district, and the remaining counties be the western district; and that the Second Term shall commence on the first Monday in July next, thereafter in Camden and Washington, and be continued throughout each district in the same rotation as directed with respect to the first circuit.
INFERIOR COURT, four times a year.
 Commencing on the first Monday in February in Camden and Washington, the second Monday in Glynn and Greene, the third Monday in Liberty and Franklin, the Monday after in Chatham and Wilkes, the Monday two weeks after in Effingham and Richmond, and the Monday week thereafter in Burke county.
