The following information, extracted from the Judiciary Law, is given for the benefit of the Sheriffs, Clerks, and all others concerned in the Courts, as the faid Law cannot be printed immediately, viz.

SUPERIOR COURT, truice a year. First Term commencing in Camden and Washington, the first on Monday in January next, the Monday after in Glynn and Greene, the Monday after in Liberty and Franklin, the Monday after in Chatham and Wilkes, the second Monday after in Effingham and Richmond, and the Monday after in the county of Burke, and that the counties from Burke to Camden inclusive be the eastern difrid, and the remaining counties be the western diffrict; and that the Second Term fhall commence on the first Monday in July next, thereafter in Camden and Washington, and be continued throughout each diffrict in the fame rotation as directed with respect to the firft circuit.

INFERIOR COURT, four times a year.

Commencing on the first Monday in February in Camden and Washington, the second Monday in Glynn and Greene, the third Monday in Liberty and Franklin, the Monday after in Chatham and Wilkes, the Mondy two weeks after in Effingham and Richmond, and the Monday week thereafter in Burke county.
