A Message from the Senate by their Secretary, Mr. Watkins.

The Senate have concurred in the resolution of this House, authorizing the appointment of an additional Notary Public for the city of Savannah, and the ballots being taken are as follow:

David Monroigut, 12.
James Clay, 12.
Benjamin Sheftall, 12.

Ordered, That Mr. Stirk do carry the said nomination to the Senate.

Resolved, That Robert Seagrove and Daniel McLean be, and they are hereby appointed Lumber Measurers for the county of Camden; and that Benjamin Sheftall, William Spencer, and George Farris, be, and they are hereby appointed Lumber Measurers for the port of Savannah; and that John Jackson be appointed for the county of Liberty, and John Goode for the county of Glynn.

And the said resolution being again read, was agreed to by the House.

A message from the Senate by their Secretary, Mr. Watkins.

Mr. Speaker,

The Senate have passed your resolution directing and requiring the Treasurer to receive no payment in discharge of any monies due or owing to the state, but gold and silver, or the paper medium, sent up for concurrence, with an amendment, they do request your concurrence. And he withdrew.

And the amendment being read, is as follows:

Between the words "medium" and except, insert, "issued under authority of an Act passed the 14th day of August, 1786, entitled, "An Act for emitting the sum of fifty thousand pounds in bills of credit, and for establishing a fund for the redemption of the same, and for other purposes therein mentioned," such paper medium to be received until the 14th day of August next, and no longer.

And the resolution, with the amendment, being read,

Resolved, That the House do concur therein.

Ordered, That Mr. James Jones do acquaint the Senate thereof.

The House proceeded to take up the message from the Senate, appointing Thomas Wyly a justice of the Peace for Effingham county, John Mitchell and Etheldred Wood, as justices for the county of Greene, and Farr Williams, Raymond Demere, jun. and Moses Cree, be added to the list of Justices for the county of Glynn.

And the same being read, was concurred in.

Ordered, That the Clerk do acquaint the Senate thereof.

A message from the Senate by their Secretary, Mr. Watkins.

Mr. Speaker,

I am directed by the Senate to inform your House, that the Senate have passed the following resolution:

Resolved, That Parry Wilson, John Wal-

ton, John Appling, Sherwood Bugg, Clementius Davis, Henry Hampton, William Lee, Robert Walton, Brittain Dawson, Thomas Haynes, Joseph Ferguson, John Stewart, John Foster, Philip Clayton, Fitz Morris Hunt, and Thomas Watkins, be inserted in the list of justices for the county of Richmond.

And the said message being read,

Resolved, That this House doth concur therein.

Ordered, That Mr. Carr do acquaint the Senate thereof.
