

IN COUNCIL.

SAVANNAH, JAN. 13, 1820.

Whereas, immediate relief and assistance to the suffering and houseless inhabitants of this city, has become the indispensable duty of Council, and all the funds capable of appropriation, must be employed in this object and used as early as possible; and whereas, notwithstanding this determination, the means of Council are inadequate to the purpose, and from necessity are obliged to curtail their wishes; and but partially relieve the distressed; And this board believing that much aid may be immediately obtained by an application to the generosity, humanity and feeling of our fellow citizens:

It is therefore *Resolved*, that the Mayor do order printed statements of the late calamity to this city by fire, to be communicated to the Justices of the Inferior Court or others of this State, calling upon their exertions in favor of the sufferers of this city, and praying that the sums collected by either of them be remitted as early as possible to the Mayor, Aldermen Harris, Bourke and Herbert; or either of them, Council pledging themselves and do hereby resolve that the amounts thus collected in this State, shall be exclusively applied to the assistance, relief and comfort of those most in want of the aid of this charitable fund.

Resolved, that copies of this resolution together with a statement of the sufferings of this city, be immediately forwarded to the Cities or Towns of Darien, Augusta, Milledgeville, St. Marys, Washington, Sparta, Eatonton, Greensborough and Madison, and that the same be addressed to the following gentlemen, respected amongst others of their fellow citizens, for their Charity, Humanity and Benevolence.
